ABOUT THE COURSE

We offer a complete, professionally taught Driver Education Course as per NYSED. Under current COVID guide lines, the in car curriculum must be covered under "parental supervision". All parents will be emailed curriculum and training guidance for their portion of the program. Parents that choose option A will receive a credit of 4 private driving lessons provided by the school's in-car contractor. These lessons are set to your child's convenience and conducted one -on -one at a location of your choosing. Contact info will be included with curriculum guide. This course is not intended to bring a new driver to higher levels of driving performance without adequate practice time outside course hours, nor is this course designed to spend more time than is required to cover the basic elements of the NY State road test.

WHAT THE COURSE OFFERS

Students will receive an MV-285 (Course Completion Certificate) from the district 3-4 weeks after the completion of the entire course . This provides an insurance reduction to students who qualify; and a driver's license Class D at age 17 upon successfully passing the NY State road test & submitting their MV-285 to DMV.

ELIGIBILITY

Students must be 16 by the first day of the program. Students must also acquire a NY State Learner's Permit (MV-100) before the first class. **"If enrollment exceeds the maximum number of allowable participants (50), preference will be sorted by birthdate (oldest to youngest)."** Enrollment is open to in-district and out of district students, however in-district students will have priority.

COST

\$520.00 for Option A, \$350 for Option B, payable by check made out to the Oyster Bay-East Norwich Central School District. There will be a \$27 fee for all returned checks.

REFUND POLICY

If a student can not be accommodated because classes are filled, all monies will be returned or refunded. If a student is scheduled for classes, they may make a formal schedule change request at the schedule posting date. If a student can not be accommodated, all monies will be refunded. Late requests for schedule changes will incur a \$50.00 administrative fee if the student drops out. **In any case, once classes begin, no tuition refund will be authorized for any reason, illness, injury, etc.**

ABSENCES/MAKE-UPS

1. By OYSTER BAY-EAST NORWICH CENTRAL SCHOOL DISTRICT regulations, Attendance will be taken as students sign on to Google Meet.

2. If you sign into the meet after I have completed attendance and it is after the exact time the class is scheduled to start, you will be marked absent. This is important to understand.

3. After I have taken attendance, I post in the Meet Chat that attendance is complete. I screen shot where the name of the absent student should be. I then send an email informing the student they have been marked absent. If I see you have entered after I have taken attendance, I will remove you from the meet. This is to avoid confusion as to whether you were in attendance. There may be times I cannot do this; but if you received an email stating that you were absent...you are absent.

4. There are NO excused absences. I only have one chance to take attendance, so the best way to avoid being marked absent is to enter the Google Meet early. I open the meet approximately 15 minutes prior to the start time. It's best to think about it this way: Being on time, means being early.

I will always be communicating with you via your OBEN email address. You are required to continually check that email and the Driver Education Google Classroom for information regarding the course.

STUDENT OBLIGATIONS

1) I will always obey all New York State vehicle and traffic laws.

2) I understand that I must successfully complete **both** the road and theory portions of the course in order to receive a MV 285.

3) I will conduct myself at all times in both car and lecture classes in a responsible manner.

4) I understand that all cell phones, pagers, etc., must be turned off during both in-car and lecture classes.

5) I understand the Absence/Make-up section of this application.

6) I understand that in order to take advantage of the road portion of the course that I must gain additional practice time with my parent/legal guardian during approved hours.

7) I understand that **50 hours of supervised instruction** is required (MV-262) when applying for a license under the age of 18.

8) In the event of a collision during the conduct of the car class, I will give a full and detailed statement to the driving school regarding that collision.
